A RESOLUTION URGENTLY REQUESTING THE NATIONAL ELECTRIFICATION ADMI-NISTRATION TO RESTRAIN LEYECO V MANAGER ROSALINO M. CULALIC FROM HOLDING HIS SCHEDULED ELECTION FOR DIRECTORS IN ORMOC CITY NORTH DISTRICT ON APRIL 26, 1984, DUE TO NON-COMPLIANCE WITH LEYECO V ELECTION CODE APPROVED BY THE NATIONAL ELECTRIFICATION ADMINISTRATION

"WHEREAS, it has come to our knowledge that Mr. Rosalino M. Culalic, Manager of LEYECO V, had scheduled an election for directors in Ormoc City North District for April 26, 1984, and had issued notices to only a chosen few advising the latter to immediately file their respective candidacies and then setting the deadline for filing thereafter a few days ago, instead of posting notices in the City Hall of three other conspicuous places as well as sending these notices to punong berangays and member-consumers of the district and the City Government at least thirty (30) days prior to the said election;

"WHEREAS, these acts of the LEYECO V Manager partake of a violation of of non-compliance with the LEYECO V Election Code approved by the National Electrification Administration such that all concerned are apprehensive that Mr. Culalic is out to rig his scheduled election;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to urgently request the National Electrification Administration to restrain Mr. Rosalino M. Culalic, Manager of LEYECO V, from holding his scheduled election for Directors in Ormoc City North District on Amril 26, 1984, due to non-compliance with the LEYECO V Election Code approved by the National Electrification Administration, and do, as this Body hereby does, reflect this resolution in a telegram to NEA; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Gen. Pedro Dumol, Administrator, and Director Edith Bueno, both of NEA, D & E. Bldg., Quezon Avenue, Quezon City; Mr. Rosalino M. Culalic, Manager, LEYECO V, and the City Legal Officer, both in Ormoc City; "CARRIED UNANIMOUSLY."
