RESOLUTION NO. 1555

A RESOLUTION TO AUTHORIZE THE CITY LEGAL OFFICER TO FILE INJUNCTION PROCEEDINGS AGAINST LEYECO V MANAGER ROSALINO M. CULALIC IN ORDER TO RESTRAIN THE LATTER FROM HOLDING HIS SCHEDULED ELECTION FOR DIRECTORS IN ORMOC CITY NORTH DISTRICT ON APRIL 26, 1984, DUE TO NON-COMPLIANCE WITH LEYECO V ELECTION CODE APPROVED BY THE NATIONAL ELECTRIFICATION ADMINISTRATION.

"WHEREAS, Mr. Rosalino M. Culalic, Manager of LEYECO V, had scheduled an election for directors in Ormoc City North District on April 26, 1984, without sending notices to member-consumers of the district, punong barangays and the City Government, except to a selected few who were advised to file their candidacies while immediately fixing the deadline for filing thereafter and neither were notices posted in the City Hall and three other conspicuous places at least thirty (30) days prior to the scheduled election; and

"WHEREAS, these acts of the LEYECO V Manager are in gross violation of the LEYECO V Election Code approved by the National Electrification Administration;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to authorize the City Legal Officer to file the necessary injunction proceedings against Mr. Rosalino M. Culalic, Manager of LEYECO V, in order to restrain the latter from holding his scheduled election for directors in Ormoc City North District on April 26, 1984, due to non-compliance with or in violation of the LEYECO V Election Code approved by the National Electrification Administration; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Gen. Pedro Dumol, Administrator, and Director Edith Bueno, both of the National Electrification Administration, D & E Bldg., 1050 Quezon Ave., Quezon City; the Executive Judge, Regional Frial Court, and the City Legal Officer, both in Ormoc City;
