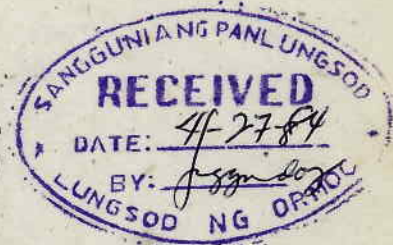

RESOLUTION NO. 1558

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO CREATE  
A SPECIAL COMMITTEE TO AUDIT LEYECO V. AND MAKE A REPORT

"WHEREAS, as member-consumers of the Leyte V Electric Cooperative (LEYECO V) we would like to be informed how finances are being managed or handled by the management of LEYECO V and this calls for a body or committee to examine the cooperative's books of accounts pursuant to the provisions of Section 5 under Article I of the By-Laws of the Leyte V Electric Cooperative;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded by Kagawad Hermosilla; be it

"RESOLVED, to authorize the Honorable City Mayor to create a Special Committee to Audit LEYECO V and do, as this Body hereby does, request the said special committee to render a report of its audit for the satisfaction of the member-consumers of LEYECO V; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Mme. Imelda Romualdez-Marcos, Minister of Human Settlements, Malacañang, and Gen. Pedro Dumol, Administrator, National Electrification Administration, D & E Bldg., 1050 Quezon Ave., Q.C., both in Metro Manila; the General Manager and the Board President, both of LEYECO V, Ormoc City;
