A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST THE
20% ECONOMIC DEVELOPMENT FUND THE SUM OF TEN THOUSAND PESOS TO
PAY LABOR AND MATERIALS FOR OVERHAULING, RECONDITIONING, ADJUST-
MENT AND OTHER SERVICES FOR THE "CARRY ALL" SERVICE VEHICLE, IN
LINE WITH MLG MC NO. 83-4 OF FEBRUARY 7, 1983, PER RETURN INDORSE-
MENT OF THE REGIONAL DIRECTOR OF MARCH 16, 1984.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Mendola,
seconded by Kagawad Tugonon;

"RESOLVED, to authorize the City Treasurer to charge against the
20% Economic Development Fund the sum of Ten Thousand Pesos (P10,000.00)
said sum or so much thereof as may be necessary to be made available for
payment of labor and materials in connection with the engine overhaul-
ing, oil gauge installation, lower and upper suspensions reconditioning,
door adjustment and welding, and signal lights installation for the "car-
ry all" service vehicle, in line with Memorandum Circular No. 83-4 dated
February 7, 1984, of the Ministry of Local Government, and per return in-
dorsement dated March 16, 1984, of the MLG Regional Director; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
City Treasurer, the City Budget Officer, the Supervising Local Government
Officer, and the City Planning Coordinator, all of Ormoc City;
