RESOLUTION NO. 1570

A RESOLUTION INTERPOSING NO OBJECTION TO THE 3-DAY PINTAKASI (JULY 30-AUGUST 1, 1984) SPONSORED BY THE ORMOC CITY SOUTH DISTRICT SCOUTING COMMITTEE AT THE NADONGHOLAN COCKPIT PROVIDED THAT THEY COMPLY WITH THE RULES AND REGULATIONS OF THE PHILIPPINE GAMEFOWL COMMISSION.

"WHEREAS, Mr. Sotero M. Pepito, Chairman, South District Scouting Committee, in his letter of May 30, 1984, has requested passage of a resolution granting the Nadongholan Cockpit to hold a 3-day 'pintakasi' on July 30, 31 and August 1, 1984, sponsored by his committee to raise funds for their scouting projects;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded jointly by Mga Kagawad Tugonon and Mendola; be it

"RESOLVED, to interpose no objection to the 3-day 'pintakasi' on July 30, 31 and August 1, 1984, sponsored by the Ormoc City South District Scouting Committee at the Nadongholan Cockpit, a duly licensed establishment in Ormoc City; Provided, However, that the said committee comply with the rules and regulations of the Philippine Gamefowl Commission; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Philippine Gamefowl Commission, Tacloban City; the Station Commander, Integrated National Police, the City Treasurer, the Chairman, South District Scouting Committee, and the Proprietor, Nadongholan Cockpit, all in Ormoc City;
