RESOLUTION NO. 1573

A RESOLUTION TO ENDORSE RESOLUTION NO. 02, C.S., OF THE BARANGAY  
SANGGUNIANG OF LINAO REQUESTING THE HONORABLE CITY MAYOR TO  
APPOINT MR. ANASTACIO QUILANTANG AS KAGAWAD BARANGAY VICE -

Barangay Linao, all in the City of Ormoc;
