RESOLUTION NO. 1574

A RESOLUTION EARNESTLY REQUESTING THE BUREAU OF LAND TRANSPORTATION
TO ALLOW ORMOC CITY TO INCREASE THE NUMBER OF UNITS OF MOTORIZED
TRICYCLES TO OPERATE HEREIN BY TEN PERCENT (10%) (FROM 300 to 330)

"WHEREAS, due to high maintenance costs not a few passenger jeep-
neys plying within short distances have stopped operation leaving the
areas to some motorized tricycles which could not cope up with the
transportation demands of barangay residents;

"WHEREAS, there is a dire need to increase the number of units
of motorized tricycles now in operation in the city by ten percent
(10%), that is, from the present 300 to 330 units, to suffice the
transportation needs of our constituents inasmuch as passenger jeep-
neys are falling out of their lines;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded By Ka-
gawad Hermosilla; be it

"RESOLVED, to earnestly request the Bureau of Land Transporta-
tion to allow Ormoc City to increase the number of units of motorized
tricycles to operate herein by ten percent (10%), that is, from the
present 300 to 330 units, to cope up with the transportation needs
of this city; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Col. Mariano Santiago, Director, Bureau of Land Transportation, East
Avenue, Quezon City; the Motor Vehicle Registrar, B.L.T., and the City
Engineer and the City Treasurer, all in Ormoc City;

"CARRIED UNANIMOUSLY."
