RESOLUTION NO. 1576

A RESOLUTION EARNESTLY REQUESTING HON. EDUARDO ROMUALDEZ, BOARD
CHAIRMAN, AND HON. ROMAN A. CRUZ, JR., PRESIDENT, OF THE
PHILIPPINE AIRLINES TO RESCHEDULE PAL FLIGHTS TO AND
FROM ORMOC CITY

"WHEREAS, the people of Ormoc and neighboring municipalities were
already elated to read in the newspapers the inclusion of Ormoc City
in the schedule of the Philippine Airlines domestic flights but such
elation only faded away with the cancellation and non-conformance of
the said schedule;

"WHEREAS, the Ormoc Airport has been tremendously improved and
prepared for availability of aircrafts for the benefit of air commut-
ers not only from this city but also from the neighboring towns;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded unani-
mously by all the other Mga Kagawad present; be it

Chairman, and Hon. Roman A. Cruz, Jr., President, of the Philippine
