RESOLUTION NO. 1578

A RESOLUTION EARNESTLY REQUESTING ALL CITY OFFICIALS AND EMPLOYEES
TO CONTRIBUTE TWO PERCENT (2%) OF THEIR ONE-MONTH SALARIES BUT
NOT LESS THAN TEN PESOS (P10.00) FOR THE MONTH OF JUNE, 1984,
FOR THE 1984-ORMOC CITY FESTIVAL CELEBRATION

"WHEREAS, the 1984 Ormoc City Festival (June 19-July 4) celebra-
tion is now in full swing and to make it a resounding success it is
but necessary that every man, woman and child should cooperate in this
undertaking where it has been the practice for government officials and
employees, including school officials and teachers, to chip in their
share of the financial burden for this traditional celebration;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kaga-
wad Bandalan; be it

"RESOLVED, to earnestly request all city officials and employees,
as well as school officials and teachers, to contribute two percent
(2%) of their one-month salaries but not less than ten pesos (P10.00)
for the month of June, 1984, and do, as this Body hereby does, request
them, further, to evince in writing their desire to so contribute in
the fiesta celebration of the city; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
all department heads, city and national offices, in the City of Ormoc;
"CARRIED UNANIMOUSLY."
