A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
THE CURRENT APPROPRIATION ON FUEL, OIL AND SPARE PARTS OF
THE CITY ENGINEERING DEPARTMENT THE SUM OF SIX HUNDRED SIXTY
PESOS (P660.00) TO SETTLE OUTSTANDING OBLIGATIONS WITH THE
RIZAL HARDWARE AND GENERAL MERCHANDISE INCURRED LAST CALENDAR
YEAR ON FOUR 12' LENGTH (4M) DOOR TRUCKS USED IN THE CONSTRU-
TION OF THE MANPOWER TRAINING CENTER.

ces of 12' (4m) length door trucks used in the construction of the
Manpower Training Center; and

Ormoc City;
