RESOLUTION NO. 1588

A RESOLUTION TO OPPOSE ANY INCREASE IN ELECTRICITY RATES OUTSIDE
OF P.A.S.A.R. FOR THE UTILITY OF THE POWER BARGE IN ISABEL.

"WHEREAS, a power barge is once again installed in Isabel, Leyte, as a stand-by power for the Philippine Associated Smelting and Refining (PASAR) Corporation and, for that matter, the National Power Corporation might increase anew its power rates in other areas of LEYECO V that do not utilize this power barge;

"WHEREAS, if the National Power Corporation increases its electricity rates because of the power barge installation such increase should be imposed only on P.A.S.A.R. inasmuch as it is the only entity that avails itself of the power barge in Isabel, Leyte;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, unanimously seconded by all the other Mga Kagawad present; be it

"RESOLVED, to oppose any increase in electricity rates imposed by the National Power Corporation outside of P.A.S.A.R. for the utility of the power barge installed in Isabel, Leyte; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Gabriel Y. Itchon, President, National Power Corporation, Quezon Ave. Cor. BIR Rd., Diliman, Quezon City; all municipalities under LEYECO V; the General Manager and the President of the Board, both of LEYECO V, Ormoc City;
