RESOLUTION NO. 1589

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE AGREEMENT WITH THE HONORABLE DEPUTY MINISTER OF LOCAL GOVERNMENT FOR THE AVAILABILITY FOR ORMOG CITY OF FOUR (4) UNITS OF DUMP TRUCKS AT P375,000.00 EACH THROUGH THE UTILIZATION OF THE PROCEEDS OUT OF THE A.I.D. LOAN NO. 492-T-035 PRECEDED BY USAID LOAN NO. 492-T-050 UNDER THE RURAL DEVELOPMENT LOAN AS AUTHORIZED BY THE PRESIDENT.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Larrazabal, seconded jointly by Mga Kagawad Mendola and Santiago;

"RES OLVED, to authorize the Honorable City Mayor, for and in behalf of the City of Ormoc, to sign the Agreement with the Honorable Deputy Minister of Local Government for the availability for Ormoc City of four (4) units of dump trucks at P375,000.00 each through the utilization of the proceeds out of the A.I.D. Loan No. 492-T-035 preceded by USAID Loan No. 492-T-050 under the Rural Development Loan as authorized by the President; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Salvador P. Socrates, Deputy Minister, Ministry of Local Government, Merryland Building, 1373 E. Rodriguez Avenue, Quezon City; the City Engineer, the City Treasurer, the City Budget Officer and the Senior Local Government Officer, all in Ormoc City;
