RESOLUTION NO. 1590

A RESOLUTION TO DECLARE THE PORTION OF PADRE ISMAEL CATAAG STREET  
FROM ITS CORNER ON ARRADAZA STREET FROM THE WEST TO ITS OPPOSITE  
CORNER ON SAN PEDRO STREET ON THE EAST AS A ONE-WAY TRAFFIC FOR  
MOTOR VEHICLES FROM 6:00 A.M. TO 6:00 P.M. DURING SCHOOL DAYS

"WHEREAS, the Reverend Sister President of St. Peter's College of Ormoc had requested the declaration of a certain portion of Padre Ismael Cataag Street from the West to the East along the southern side of the college compound as a one-way vehicular traffic from 6:00 a.m. to 6:00 p.m. during school days (Monday to Friday) for the safety of students, specially the little graders;

"WHEREAS, the making of such portion a one-way traffic for motor vehicles will redound to the preservation if not protection of life and limb in that vicinity;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to declare the portion of Padre Ismael Cataag Street from its corner on Arradaza Street from the West to its opposite corner on San Pedro Street on the East as a one-way traffic for motor vehicles from 6:00 o'clock in the morning until 6:00 o'clock in the evening during school days (Monday to Friday); and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the Station Commander, OCINP, and the Reverend Sister President, St. Peter's College, all in Ormoc City;

"CARRIED UNANIMOUSLY."
