mously by all the other Mga Kagawad present; be it

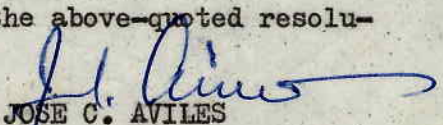
"RESOLVED, to redistribute all the barangays of District V rep-

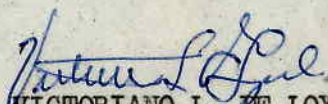

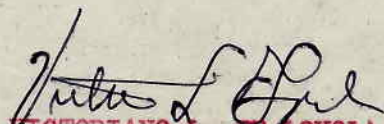
