RESOLUTION NO. 1599

A RESOLUTION CREATING A SPECIAL COMMITTEE TO DISPATCH ONCE AND FOR ALL THE MATTER OF THE REQUEST OF THE SPOUSES AGATON AND ANICETA C. PARRILLA REGARDING LOTS 2223 AND 2224 AT THE GOVERNMENT CENTER, SAID COMMITTEE TO COMPOSE THE CITY MAYOR AS CHAIRMAN, VICE-MAYOR AS CO-CHAIRMAN, AND ALL KAGAWADS AND THE CITY LEGAL OFFICER AND THE CITY FISCAL AS MEMBERS.

WHEREAS, this august Body will recall that CFT Civil Case No. 711-O Under Court of Appeals General Record (CA-G.R.) No. 50652-R for eminent domain, more prominently known as expropriations proceedings for government center site purposes of Ormoc City had already been decided and has become final as of June 20, 1979, by virtue of which a Writ of Execution had been issued on January 8, 1981, by the Court of First Instance of Leyte;

"WHEREAS, despite this final verdict, the spouses Agaton and Aniceta C. Parrilla and some occupants of Lots 2223 and 2224 within the government center site have been requesting this august Body for reconsideration on their plight which requests every now and then have been referred from one committee to another of this Body and to outside offices for further study, comment and/or opinion only to be returned to us with recommendations unfavorable to the petitioners;

"WHEREAS, it appears that the spouses and their co-petitioners are bent on pushing through their request despite odds and difficulties that they are encountering such that it behooves this Body to dispose this matter once and for all with the view to arriving at a satisfactory solution to both the City and the petitioners;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Bandalan; be it

"RESOLVED, to create a Special Committee to dispatch once and for all the matter of the request of the spouses Agaton and Aniceta C. Parrilla and others regarding Lots 2223 and 2224 at the Government Center, the said committee to be composed of the Honorable City Mayor as Chairman, the Honorable Vice-Mayor as Co-Chairman, and all Kagawads, the City Legal Officer and the City Fiscal as Members; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, the City Mayor, the Honorable Vice-Mayor, the Honorable Members (Mga Kagawad) of the Sangguniang Panlungsod, the City Legal Officer, the City Fiscal, Mr. and Mrs. Agaton Parrilla, Miss Erlinda C. Maglaoy and Basilides Apas (for the occupants), all in Ormoc City;

"CARRIED UNANIMOUSLY."
