RESOLUTION NO. 1603

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR, BUREAU OF MINES AND GEO-SCIENCES, TO FURNISH THE SANGGUNIANG PANLUNGSOD NG ORMOG A COMPLETE LIST OF SAND-AND-GRAVEL HAULING LICENSEES SHOWING THEIR RESPECTIVE DATES OF LICENSE ISSUANCE, THE AUTHORIZED VOLUME FOR EXTRACTION, AND THE AREA OF OPERATION WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF ORMOG.

"WHEREAS, this august Body would like to know all the sand-and-gravel haulers operating within the territorial jurisdiction of the City of Ormoc, including their respective dates of issuance of their licenses, their authorized volume of extraction of sand and gravel, and the particular areas of their operation;
