A RESOLUTION TO REQUEST SULPICIO LINES, INC., TO REDUCE THE NUMBER OF PORTS OF CALL OF THE M/V CEBU PRINCESS IN THE ORMOC_MANILA-ORMOC ROUTE IN ORDER TO CUT SHORT TRAVEL TIME FOR COMMUTERS

"WHEREAS, some commuters have made representations with this august Body for a possible intercession with the Sulpicio Lines, Inc., to reduce the number of ports of call of the M/V Cebu Princess in its Ormoc-Manila-Ormoc route in order to cut short their travel time back-and-forth Manila considering that it takes three days to go to Manila as the vessel will have to dock at Catbalogan, Calbayog and Masbate and also three days in coming back to Ormoc as it passes through the dame ports from Manila;

"WHEREAS, the commuters, including shippers, even suggested if it would be possible for another Sulpicio vessel to ply an Ormoc-Cebu-Manila-Ormoc route if the M/V Cebu Princess cannot dispense with the ports between Ormoc and Manila;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded by Kagawad Tugonon; be it

"RESOLVED, to request Sulpicio Lines, Inc., to reduce the number of ports of call of the M/V Cebu Princess in the Ormoc-Manila-Ormoc route in order to cut short the travel time for commuters; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the General Manager, through the Resident Manager, Sulpicio Lines, Inc., Ormoc City;

"CARRIED. Six affirmative votes; Two abstentions registered by Mga Kagawad Bandalan and Hermosilla;"
