A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE DEED
OF ABSOLUTE SALE WITH MR. ARSENIO CONUI, ET AL., COVERING 6,920
SQUARE METERS OF THEIR LOTS TRAVERSED BY THE ORMO-PATAG ROAD AT
P10.00 PER SQUARE METER AS APPRAISED BY THE ASSESSMENT DEPARTMENT,
WITH PROVISION THAT PAYMENT THEREFOR BE MADE ON INSTALLMENT BASIS

"WHEREAS, a deed of absolute sale is now being prepared for signa-
