RESOLUTION NO. 1613

A RESOLUTION URGENTLY REQUESTING THE HONORABLE MINISTER OF PUBLIC  
WORKS AND HIGHWAYS TO KINDLY EXTEND CALAMITY AID TO ORMO CITY  
OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FOR THE REPAIR OF  
THE CONCRETE ROAD ALONG BARANGAYS ALEGRIA AND PUNTA HEAVILY DA-  
MAGED BY TYPHOONS "MARING" AND "NITANG".

"WHEREAS, extraordinary big waves brought about by typhoons 'Maring'  
and 'Nitang' have caused heavily scoured shoulder and grouted riprap of  
the concrete city road along Barangays Alegria and Punta even as certain  
sections thereof are in the verge of collapse as can be seen in the pic-  
torial report submitted by the City Engineer who estimated the damage to  
the tune of Two Hundred Thousand Pesos (P200,000.00);

"WHEREAS, this road is under heavy traffic and leads to different  
densely populated barangays as Linao, Nauangan and Lao, not to mention  
the government center area such that he recommended that a shore protec-  
tion be constructed immediately in order to protect the concrete pavement  
from big waves due to typhoons and monsoon winds;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded jointly  
by Kagawad Torrevillas, Santiago, Hermosilla and Codilla; be it

"RESOLVED, to urgently request the Honorable Minister of Public  
Works and Highways to kindly extend calamity aid to Ormoc City in the  
sum of TWO HUNDRED THOUSAND PESOS (P200,000.00) for the repair of the  
concrete city road along Barangays Alegria and Punta heavily damaged by  
typhoons 'Maring' and 'Nitang'; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the Honorable Minister of Public Works and Highways, Metro Manila; the  
Regional Director, Ministry of Public Works and Highways, Kandahug, Palo,  
Leyte; and the City Engineer, Ormoc City;

"CARRIED UNANIMOUSLY."
