A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE THE SUM OF  
P2,149.16 AGAINST CURRENT APPROPRIATION ON OTHER SERVICES OF  
THE OFFICE OF THE VICE-MAYOR TO SETTLE OUTSTANDING OBLIGATIONS  
ON FREIGHT CHARGES WITH THE ABOITIZ SHIPPING CORPORATION FOR  
FURNITURE AND FIXTURES INCURRED IN 1981.
