RESOLUTION NO. 1620

A RESOLUTION TO ADOPT RESOLUTION NO. 2176 OF THE HONORABLE SANGGUNIANG PANLUNGSOD NG LUCENA VEHEMENTLY OPPOSING THE PROPOSED BILL OF DEFENSE DEPUTY MINISTER TEODULO C. NATIVIDAD INCREASING THE CONTRIBUTION OF FIRST-CLASS CITIES TO THE INP FUND FROM 18, TO 25

"WHEREAS, the Honorable Sangguniang Panlungsod ng Lucena has furnished for our adoption a copy of their Resolution No. 2176 requesting earnestly this august Body, among others, to support their bid in vehemently opposing the proposed bill of Defense Deputy Minister Teodulo C. Natividad which increases the contribution of first-class cities to the Integrated National Police aid fund from eighteen percent (18%) to a maximum of twenty-five percent $(25\frac{1}{2})$ each out of their annual income;

"WHEREAS, we concur in the embodiment of the resolution of the Honorable Sangguniang Panlungsod ng Lucena even as we deplore the fact that the City of Ormoc is not getting a fair return of its 18% contribution to the INP fund inasmuch as our police and fire departments are not substantially supplied and sufficiently financed by the Integrated National Police headquarters for their immediate needs like spare parts, tires, hoses, fuel, oil and grease and other basic necessities, not to mention the maintenance and improvement of the police and fire buildings or stations and sub-stations which up to the present are being carried on by the local administration;

WHEREAS, we would like to add that the policemen for Ormoc are getting scarce due to the fact that many of them are being assigned or detailed to other municipalities such that their present number is a far cry from the 'one policeman for every thousand population' policy to the fast deterioration of their efficiency; and

"WHEREAS, this august Body has even been contemplating to reiterate its request made sometime ago for President Marcos to return the control and supervision of the police and fire departments to the local government so that the latter can once again streamline the services and efficiency of both departments the way we used to do prior to their integration into the national force where no 18% aid to the TNP was ever involved;

Benjamin L. Romualdez, Hon. Damian Aldaba, Hon. Artemio Mate, Hon. Emiliano Melgazo, and Hon. Alberto Veloso, Batasang Pambansa, Metro Manila;
