SQUARE METERS OF LOT NO. 2267 UNDER TCT 13647 TRAVERSED BY THE  
CITY ROAD AT THE RATE OF P25.00 PER SQUARE METER

"WHEREAS, There is now being prepared a deed of absolute sale for
