RESOLUTION NO. 1626

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT BARANGAY  
DANHUG'S DONATION OF 12 UNITS, 20-WATT FLOURESCENT LAMPS, FOR THEIR  
STREET LIGHTING PURPOSES WITH ARMS AND PROTECTORS SUBJECT TO THE  
250-WATTAGE LIMITATION FOR EVERY BARANGAY PER RESOLUTION NO. 1149

"WHEREAS, the Sangguniang Barangay of Danhug in its Resolution  
No. 04, current series, has signified the intention of the Barangay  
to donate 12 units of 20-watt flourescent lamps with arms and protec-  
tors for installation to light their streets;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded by Ka-  
gawad Mendola; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the  
donation by Barangay Danhug of 12 units of 20-watt flourescent lamps  
with arms and protectors for installation for the purpose of lighting  
their streets subject, however, to the 250-wattage limitation for eve-  
ry barangay per Resolution No. 1149 dated April 20, 1982, to be shoul-  
dered by the city, otherwise, any excess thereof shall have to be borne  
by the barangay; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the City Engineer, the City Treasurer, the Sangguniang Barangay of  
Danhug, and the General Manager, LEYECO V, all in Ormoc City;
