RESOLUTION NO. 1631

A RESOLUTION TO AUTHORIZE ANY BARANGAY TO EMPLOY BARANGAY TANODS
IN EXCESS OF ELEVEN (11) MEMBERS PROVIDED THAT GSIS PREMIUMS
FOR THE SAID EXCESS SHALL BE SHOULDERED BY THE BARANGAY OUT
OF THE TEN PERCENT (10%) REALTY TAX SHARES ACCRUING THEREON

"WHEREAS, some barangays have requested this august Body that they
be allowed to employ more than the limited number of eleven (11) Baran-
gay Tanods and that the GSIS coverage premiums for the Tanods in excess
of 11 will be shouldered by them availing themselves of the ten percent
(10%) realty tax shares accruing to the barangay;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded joint-
ly by Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to authorize any barangay to employ barangay tanods in
excess of eleven (11) members: Provided, However, that Government Ser-
vice Insurance premiums for any excess thereof shall be shouldered by
the barangay out of the ten percent (10%) realty tax shares accruing
to the barangay;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer and all Sangguniang Barangays, Ormoc City;

"CARRIED UNANIMOUSLY."
