RESOLUTION NO. 1632

A RESOLUTION EARNESTLY REQUESTING THE MHS AREA MANAGER TO ALLOW  
THE MAF DISTRICT AGRICULTURAL OFFICER TO TEMPORARILY USE THE  
MHS ACTION CENTER BUILDING IN BARANGAY SIMANGAN, ORMO CITY,  
UNTIL THE CITY GOVERNMENT CAN ACCOMMODATE HIM  
IN AN OFFICE BUILDING IN THE CITY PROPER

"WHEREAS, the District Agricultural Officer in his letter of October 8, 1984, informed us that he is given only up to this day by the owner to occupy the house used as his office and artificial breeding center even as we hold pending an appropriation for four months' back rentals due to the financial stress of our city coffer such that he requested this august Body to make representations with the Ministry of Human Settlements that he be allowed to use temporarily the MHS Action Center Building in Barangay Simangan until such time that the City Government can accommodate him in an office building in the city proper;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Kagawad Torre Villas and Hermosilla; be it

"RESOLVED, to earnestly request the Area Manager, Ministry of Human Settlements, to allow the District Agricultural Officer to temporarily use the MHS Action Center Building in Barangay Simangan, Ormoc City, until such time that the City Government can accommodate him in an office building in the city proper; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Area Manager, Area Coordination Center, Ministry of Human Settlements, and the Provincial Executive Agricultural Officer, Ministry of Agriculture, both in Tacloban City; and the District Agricultural Officer, Ormoc City;
