RESOLUTION NO. 1634

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, THROUGH THE CITY LEGAL OFFICER, TO FILE EXPROPRIATION PROCEEDINGS ON LOTS 2475, 2476, 2477, 2478, 2479 AND 2480 HAVING AN AGGREGATE AREA OF SIX HUNDRED SEVENTY-ONE (671) SQUARE METERS BELONGING TO EULALIA MAURO, IGNACIO SANTILLAN, CORNELIA LABANAN, GERONIMO REGULACION AND THE PANGILINANS SITUATED IN BARANGAY ALEGRIA FOR PURPOSES OF THE CITY SLAUGHTERHOUSE AND LIVESTOCK MARKET SITE.

"WHEREAS, for purposes of the city slaughterhouse and livestock market site, our Committee on Public Properties, having been authorized by this august Body, in company with the City Veterinarian have made a series of negotiations with the owners and administrators of Lots 2475, 2476, 2477, 2478, 2479 and 2480 having an aggregate area of six hundred seventy-one (671) square meters situated in Barangay Alegria being the most ideal place or site considering its proximity to the public market wherefor the City offered a very reasonable price for the lots to the satisfaction of the owners;

"WHEREAS, despite several pleadings with the owners to the extent of offering them city lots in some relocation centers in exchange for their lots to be acquired by the City, the said owners remain adamant to this day such that the City finds no other recourse than to expropriate these lots for purposes of the city slaughterhouse and livestock market site;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torrevillas; be it

RESOLVED, to authorize the Honorable City Mayor, through the City Legal Officer, to file expropriation proceedings on the following lots in Barangay Alegria for purposes of the city slaughterhouse and livestock market site:






