RESOLUTION NO. 1638

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT FERDINAND E. MARCOS, THRU THE MINISTRY OF LOCAL GOVERNMENT, TO RAISE THE REPRESENTATION ALLOWANCES OF THE MAYOR FROM P600 TO P1,000 AND OF THE DEPARTMENT HEADS FROM P350 TO P700 EACH PER MONTH

"WHEREAS, despite inflation the Mayor's representation allowance of P600 and the department heads' of P350 per month have remained the lowest for the last 13 years by virtue of Memorandum Circular No. 437 dated February 22, 1971, of the Office of the President, while officials of Ministries of Justice and Finance, among others, are even granted housing allowances aside from their representation allowances;

"WHEREAS, it can never be gainsaid that local officials, especially the Mayor, are always and ever solicited for voluntary contributions, almsdeeds and other monetary assistance not only for community projects but also personal necessities of solicitors such that their representation allowances have become insufficient to entertain solicitors whereupon they are compelled to chip in from their own personal funds after exhaustion of their allowances;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the other Kagawad present; be it

"RESOLVED, to earnestly request His Excellency, President Ferdinand E. Marcos, through the Ministry of Local Government, to raise the representation allowances of the Mayor from P600 to P1,000 and of the department heads from P350 to P700 each per month; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, the Honorable Deputy Prime Minister Jose A. Roño, Batasang Pambansa, and the Honorable Gaudioso C. Osmeña, Jr., Executive Secretary (Director), Bureau of Local Government Supervision, 4th Floor, Victoria I Bldg., Cor. Bohol & Queson Aves., Q.C., all in Metro Manila; and the Regional Director, Ministry of Local Government, Region VIII, Tacloban City;

"CARRIED UNANIMOUSLY."
