RESOLUTION NO. 1644

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE  
DONATION OF THE SANGGUNIANG BARANGAY OF ALEGRIA OF TWO UNITS  
OF FLOURESCENT LAMPS, 20 WATTS, EACH, FOR INSTALLATION IN THE  
PREMISES OF THE ALEGRIA-BATUAN SCHOOL CAMPUS, SUBJECT TO THE  
250-WATT LIMITATION FOR EVERY BARANGAY, PER RESOLUTION 1149

"WHEREAS, the Sangguniang Barangay of Alegria, in its Resolution  
No. 9, current series, has intended to donate two (2) units of 20-watt  
flourescent lamps for installation at the Alegria-Batuan community  
school campus: one at the entrance of the school at the side walling  
of the shop building and the other at the side walling of the home  
economics building;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly  
by Kagawad Torrevillas and Hermosilla; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in be-  
half of the City Government, to accept the donation of the Sangguniang  
Barangay of Alegria of two units of 20-watt flourescent lamps for ins-  
tallation at the Alegria-Batuan community school campus: Provided, how-  
ever, That the 250-watt limitation for every barangay pursuant to Reso-  
lution No. 1149 shall not have been exceeded, otherwise, any excess  
shall have to be shouldered by the Sangguniang Barangay out of the ba-  
rangay's ten percent realty tax share; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the Sangguniang Barangay of Alegria, the City Engineer, the City Trea-  
surer, and the General Manager, LEYECO V, all in Ormoc City;

"CARRIED UNANIMOUSLY."
