CORPORATION OF THE ORMOC SHOPPING MALL, PHASE II

"WHEREAS, following the request of the Manager, Philippine Rigid Construction Corporation, for final inspection of the Project Construction of the Ormoc Shopping Mall, Phase II, in his desire to turn over the project complete as per plans, specifications and other contract requirements, the Office of the City Engineer conducted an inspection and, forthwith, recommended its acceptance;

"WHEREAS, the City Pre-Bid and Award Committee had, likewise conducted an inspection of the same project and, also, by its unnumbered resolution of November 2, 1984, had recommended that the City Government accepts such construction;
