ly by all the other Kagawads present; be it

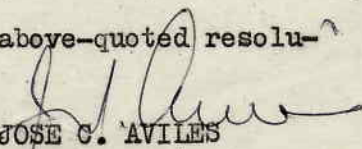
"RESOLVED, to redistribute all barangays of District III represen-

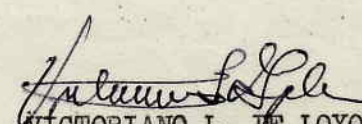
