## RESOLUTION NO. 1652

A RESOLUTION TO ADOPT RESOLUTION NO. 366-84 OF THE HONORABLE SANGGUNANG PANLUNGSOD NG OROQUIETA REMINDING HIS EXCELLENCY, PRESIDENT FERDINAND E. MARCOS, TO CONSIDER OUR SINCERE REQUEST FOR THE TRANSFER OF SUPERVISION, CONTROL AND ADMINISTRATION OF THE POLICE AND FIRE DEPARTMENTS TO THE LOCAL GOVERNMENT.

"WHEREAS, the Honorable Sangguniang Panlungsod ng Oroquieta has furnished us for our support a copy of its Resolution No. 366-84 reminding the President to consider our sincere request for the transfer of the supervision, control and administration of the police and fire departments to the local government;

"WHEREAS, we concur in the manifestations of the Honorable Sangguniang Panlungsod ng Oroquieta even as we adhere to the notion that the proposed contribution increase from 18% to 25% to the INP fund by MP Tedulo Natividad for first-class cities should not be effected because it has been the clamor of all city and municipal sanggunians to transfer the supervision, control and administration of the police and fire forces to the local government;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded unanimously by all the other Kagawads present; be it

"RESOLVED, to adopt Resolution No. 366-84 of the Honorable Sangguniang Panlungsod ng Oroquieta and do, as this Body hereby does, remind His Excellency, President Ferdinand E. Marcos, to consider our sincere request for the transfer of supervision, control and administration of the police and fire departments to the local government; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, Speaker Nicanor Yñiguez and MP Tedulo Natividad, Batasang Pambansa, all in Metro Manila; and the Honorable Sangguniang Panlungsod, City of Oroquieta;
