RESOLUTION NO. 1656

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE THE SUM OF
P52,090.00 AGAINST THE CURRENT RESERVE FOR LOTS EXPROPRIATION
UNDER THE INFRASTRUCTURE FUND ANNUAL BUDGET TO BE MADE AVAILABLE
FOR FILING EXPENSES FOR EXPROPRIATION PROCEEDINGS BEFORE THE
REGIONAL TRIAL COURT, ORMOC CITY, AFFECTING BARANGAY ALEGRIA
LOT NOS. 2475, 2476, 2477, 2478, 2479 AND 2480 WITH AN AREA
AGGREGATING 671 SQUARE METERS FOR PURPOSES OF THE CITY
SLAUGHTERHOUSE AND LIVESTOCK MARKET SITE.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besa-
bella, seconded jointly by Kagawads Mendola and Hermosilla;

"RESOLVE, to authorize the City Treasurer to charge the sum of
FIFTY THOUSAND ZERO NINETY PESOS (P52,090.00) against the current re-
serve for Expropriation of Lots under the Infrastructure Fund Annual
Budget, said sum or so much thereof as may be necessary to be made
available for filing expenses for expropriation proceedings before the
Regional Trial Court, Ormoc City, affecting Lot Nos. 2475, 2476, 2477,
2478, 2479 and 2480 all situated in Barangay Alegria having an aggre-
gate area of 671 square meters for purposes of the City Slaughterhouse
and Livestock Market site; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the City Budget Officer, the City Legal Officer,
Ms. Eulalio Mauro (c/o Emiliana Parrilla), Mr. Ignacio Santillan,

Eduardo and Ruben Jr., all surnamed Pangilinan, and the Honorable
Executive Judge, Regional Trial Court, all in Ormoc City;
