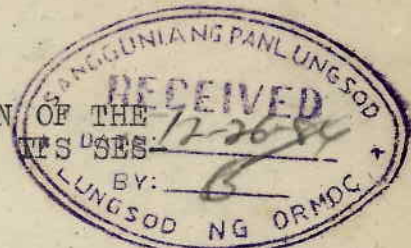


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE

RESOLUTION NO. 1667

A RESOLUTION TO ADOPT RESOLUTION NO. 361, S. 1984, OF
THE HONORABLE SANGGUNIANG PANLUNGSOD NG BACOLOD SUP-
PORTING PRESIDENT FERDINAND E. MARCOS IN DIRECTING
THE NATIONAL POWER CORPORATION AND THE NATIONAL ELEC-
TRIFICATION ADMINISTRATION TO IMMEDIATELY RATIONALIZE
AND REDUCE POWER RATES IN THE COUNTRY.

"WHEREAS, the Honorable Sangguniang Panlungsod ng Bacolod has
furnished us for our support a copy of its Resolution No. 361,
series of 1984, supporting the recent pronouncement of His Excel-
lency, President Ferdinand E. Marcos directing the National Power
Corporation and National Electrification Administration to immedi-
ately rationalize and reduce power rates in the country.

"WHEREAS, we concur in the embodiment of the resolution of the
Bacolod Sanggunian even as we adhere to the opinion that there is
an urgent need to re-evaluate and re-assess all electric coopera-
tives in the country to the extent of reorganizing them if they
are to truly serve their respective areas of responsibility and
bring about the realization of the aims and objectives of rural
electric cooperatives in the country;

"NOW, THEREFORE, on motion of Kagawad Hermosilla seconded
unanimously by all the other Kagawads present; be it;

"RESOLVED, to adopt Resolution No. 1667, series of 1984, and
do, as hereby does, support President Ferdinand E. Marcos in direc-
ting the National Power Corporation and the National Electrifica-
tion Administration to immediately rationalize and reproduce power
rates in the country;

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to His Excellency, President Ferdinand E. Marcos, and the Honorable
Sangguniang Panlungsod, Bacolod City;
