RESOLUTION NO. 1676

A RESOLUTION EARNESTLY REQUESTING HON. JESUS T. TANCHANCO, MINISTER, NATIONAL FOOD AUTHORITY THROUGH THE REGIONAL DIRECTOR TO OPEN ADDITIONAL KADIWA OUTLETS AND/OR PUT TING UP ROLLING STORES IN STRATEGIC LOCATIONS IN ORMOC CITY CONSIDERING THAT HEAVY TURN OUT OF BUYERS CAN NOT BE SERVED WITH ONLY ONE KADIWA STORE.

"WHEREAS, the Members of this Sangguniang Panlungsod, have noted, with deep concern and pity on the plight of the majority of Ormoc residents, who are solely dependent on Kadiwa food items and patronizing our one and only Kadiwa outlet in Ormoc City;

WHEREAS, these Kadiwa buyers, go to the Kadiwa store a s. early as 6:00 or 7:00 o'clock in the morning; falling in line to wait for turn to buy; but considering their number, these buyers can not be served immediately, and therefore have to wait for quite a time, before they are able to buy their needs;

"WHEREAS, Ormoc City, is a growing City with a population of about 125,000 more or less;

"WHEREAS, most of our Kadiwa buyers are from the barangays and have to spend so much time to come to the city; if only to buy their needs; not to mention also the fact that majority of these people come to the city to look for their needs on Sundays;

"WHEREAS, considering the above situation, the one and only Kadiwa outlet in Ormoc City can not sufficiently or adequately meet the demands for services by our buying public;

WHEREFORE, on motion of Kagawad Besabella, seconded by a 1 1 the rest of the Kagawads present; be it

"RESOLVED, to earnestly request the Honorable Minister of the National Food Authority, through its Regional Director, Tacloban City, to open additional Kadiwa outlets in Ormoc City, which shall open for business, as early as 7:00 o'clock in the morning and t h e whole day of Sundays, and/or to provide in Ormoc City, NFA Kadiwa rolling stores in strategic locations to better serve our consuming public;
