RESOLUTION NO. 1677

A RESOLUTION GRANTING A CITY FRANCHISE TO THE ORMOC CITY
TELEPHONE COMPANY, INC. TO OPERATE, INSTALL AND MAINTAIN
AN AUTOMATIC TELEPHONE SYSTEM IN THE CITY OF ORMOC AND
SUBURBS FOR A PERIOD OF 25 YEARS.

"WHEREAS, this august Body finds it necessary in the interest of
public welfare, to grant a city franchise to operate, install and main-
tain an automatic telephone system in the City of Ormoc, in accordance
with law the rules and regulations promulgated by the National Telecom-
munications Commission and the Ministry of Transportation and Communi-
cations;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded jointly
by Mga Kagawad Hermosilla and Codilla; be it

"RESOLVED, to grant a city franchise to the Ormoc City Telephone
Company, Inc., to operate, install and maintain an automatic telephone
system in the City of Ormoc and Suburbs for a period of 25 years, in
accordance with law, the rules and regulations promulgated by the Na-
tional Telecommunications Commission and the Ministry of Transportation
and Communications;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Securities & Exchange Commission, the National Telecommunications
Commission, the Ministry of Transportation and Communications, all of
Metro Manila; and the President, Ormoc City Telephone Co., Ormoc City.
