RESOLUTION NO. 1677

A RESOLUTION GRANTING A CITY FRANCHISE TO THE ORMOG CITY  
TELEPHONE COMPANY, INC. TO OPERATE, INSTALL AND MAINTAIN  
AN AUTOMATIC TELEPHONE SYSTEM IN THE CITY OF ORMOG AND  
SUBURBS FOR A PERIOD OF 25 YEARS.

"WHEREAS, this august Body finds it necessary in the interest of public welfare, to grant a city franchise to operate, install and maintain an automatic telephone system in the City of Ormog, in accordance with law the rules and regulations promulgated by the National Telecommunications Commission and the Ministry of Transportation and Communications;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded jointly by Mga Kagawad Hermosilla and Codilla; be it

"RESOLVED, to grant a city franchise to the Ormog City Telephone Company, Inc., to operate, install and maintain an automatic telephone system in the City of Ormog and Suburbs for a period of 25 years, in accordance with law, the rules and regulations promulgated by the National Telecommunications Commission and the Ministry of Transportation and Communications;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Securities & Exchange Commission, the National Telecommunications Commission, the Ministry of Transportation and Communications, all of Metro Manila; and the President, Ormog City Telephone Co., Ormog City.
