RESOLUTION NO. 1680

A RESOLUTION GRANTING THE REQUEST OF THE PRESIDENT,
ORMOC CITY FILIPINO RETAILERS' ASSOCIATION, INC. AL-
LOWING THEM TO PAY THE CITY MAYOR'S PERMIT AND CITY
LICENSE FEES WITHOUT PENALTIES UNTIL JANUARY 31, 1985
INSPIRE OF THE DEADLINE AS OF JANUARY 20, 1985.

"WHEREAS, the Filipino Retailers' Association, Inc. through its President has requested extension for payment of Mayor's Permit fees and City Licenses from January 21 to January 31, 1985 considering that most of them and all other tax payers have had hard time in securing enough money to pay said licenses, and, temporarily suspending for this purpose, the operation of Section 1.2.1.4. of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1987" fixing the first twenty (20) days of January to pay tax obligations;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded jointly by mga Kagawad Mendola and Codilla, be it

"RESOLVED, to grant the request of the President, Ormoc City Filipino Retailers' Association, Inc. allowing them and all tax payers, similarly affected, to pay the City Mayor's Permit and City License fees without penalties until January 31, 1985 inspite of the January 20, 1985, deadline;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer and his City License Clerks and the President, Filipino Retailers' Association, all in Ormoc City;

"CARRIED UNANIMOUSLY."
