RESOLUTION NO. 1685

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 03
DATED OCTOBER 19, 1984, CURRENT SERIES OF THE

all concerned on the cluster approach;

"NOW, THEREFORE, on motion of Kagawad Torre Villas secon-
ded jointly by Mga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to favorably endorse Resolution No. 03, dated
October 19, 1984, current series of the Sangguniang Barangay of
Luna signifying their intention to join the Barangay Cluster and
to commit its resources to the integrated and collective develop-
ment of the cluster;
