RESOLUTION NO. 1686

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 04,
DATED OCTOBER 19, 1984, CURRENT SERIES, OF THE
SANGGUNIANG BARANGAY OF LUNA, APPROVING THE INTEGRATED
CLUSTER DEVELOPMENT PLAN AND TO COMMIT ITSELF
TO ITS IMPLEMENTATION.

"WHEREAS, this august Body has received Resolution No. 04
dated October 19, 1984, among others that on October 17, 1984
Barangay Dolores, Concepcion, San Pablo, Dayhagan, Milagro,
Juaton and Luna have duly constituted themselves into a Baran-
gay Cluster as an integrated area for rural development and
have accordingly elected barangay cluster officers and represen-
tatives;

"WHEREAS, after its organization a cluster Planning and Ma-
nagement Board was created and convened in a Planning Workshop
during which an integrated Cluster Development Plan was prepared
and drawn up;

"WHEREAS, said integrated cluster plan contains a package of
attainable cluster objective which have been translated into spe-
cific programs/projects for implementation; and embodies the hopes
of the residents of Barangay Luna;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded
jointly by Mga Kagawad Mendola and Hermosilla;

"RESOLVED, to approve the Integrated Cluster Development Plan
and to commit itself to its implementation;

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Senior Local Government Officer, MLG, the City Planning and
Development Office, and the Barangay Sanggunian of Luna, all in
Ormoc City;
