RESOLUTION NO. 1687

A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 05,
DATED OCTOBER 19, 1984, CURRENT SERIES OF THE SANG-
GUNANG BARANGAY OF JUATON SIGNIFYING THEIR INTEN-
TION TO JOIN THE BARANGAY CLUSTER AND TO COMMIT
ITS RESOURCES TO THE INTEGRATED AND COLLECTIVE DE-
VELOPMENT OF THE CLUSTER.

morandum Circular No. 79-8 dated January 29, 1979 and further

22, 1980, which provides for the implementing guidelines of
all concerned on the cluster approach;

"NOW, THEREFORE, on motion of Kagawad Torrevillas secon-
ded jointly by Nga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to favorably endorse Resolution No. 05, dated
October 19, 1984, current series of the Sangguniang Barangay
of Juaton signifying their intention to join the Barangay
Cluster and to commit its resources to the integrated and
collective development of the cluster;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the Senior Local Government Officer, MLG, the City
Planning and Development Office, the Barangay Sanggunian of
Juaton, all in Ormoc City;
