- A RESOLUTION REITERATING OUR REQUEST FOR ADDITIONAL KADIWA OUTLETS IN ORMOC CITY, THROUGH THE KIND INTERCESSIONS OF THE HONORABLE MADAME IMELDA ROMUALDEZ-MARCOS AND HONORABLE BENJAMIN ROMUALDEZ, PROVINCIAL GOVERNOR OF LEYTE.

"WHEREAS, this august Body on January 15, 1985, have passed and approved Resolution No. 1676 earnestly requesting the Honorable Minister Jesus T. Tanchanco, National Food Authority through the Regional Director to open additional Kadiwa Outlets and/or putting up rolling stores in strategic location in Ormoc City considering that heavy turn out of buyers can not be served with only one Kadiwa store;

"WHEREAS, the Provincial Manager, Benjamin B. Marta of the National Food Authority has turned down our request due to Management and financial constraints and other factors in the putting up of a new additional Kadiwa outlets; and also because of high operational cost, and the ban on hiring of new personnel;

"WHEREAS, this august Body finds it necessary to ask the help of the Honorable First Lady and the Provincial Governor, for their kind intercessions that this request be granted, for the benefit of our consuming public and our constituents in Ormoc City;

"NOW, THEREFORE on motion of Kagawad Torrevillas, unanimously seconded by all the other Mga Kagawad present; be it

"RESOLVED, to reiterate our request for additional Kadiwa outlets in Ormoc City, through the kind intercessions of the Honorable Madame Imelda Romualdez-Marcos and Honorable Benjamin Romualdez, Provincial Governor of Leyte;
