A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION ON AID TO NUTRITION COUNCIL THE SUM OF NINE THOUSAND NINE HUNDRED PESOS (P9,900.00) FOR PAYMENT OF MONTHLY ALLOWANCES OF NUTRITION SCHOLARS FOR THE PERIOD FROM AUGUST TO DECEMBER 31, 1984
