A RESOLUTION APPROVING THE LOCAL SCHOOL BOARD BUDGET FOR CALENDAR YEAR 1985 WITH A TOTAL APPROPRIATION OF P400,000.00 FROM THE CITY SHARE OF ADDITIONAL ONE PERCENT (1%) REAL PROPERTY TAX LEVIED FOR THE SPECIAL EDUCATION FUND.
