RESOLUTION NO. 1704

A RESOLUTION ACKNOWLEDGING THE ASSUMPTION TO OFFICE OF THE NEWLY APPOINTED KAGAWADS, HONORABLE MANUEL T. FIEL, VICE CESAR S. SAMSON, DECEASED, AND HONORABLE JOSE C. ALFARO, JR., VICE DIONISIO S. SANTIAGO, RESIGNED, PURSUANT TO THE APPOINTMENT SIGNED BY HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS, DATED FEBRUARY 1, 1985 AND INDORSED BY THE HONORABLE MINISTER OF LOCAL GOVERNMENT DATED FEBRUARY 20, 1985.

"WHEREAS, it is of public knowledge that the Sangguniang Panlungsod ng Ormoc has two seats vacant vacated by the late Cesar S. Samson and Dionisio S. Santiago, resigned, so that it behooves that this august Body will openly accept the newly appointed Kagawads to fill up the vacancies;

"NOW, THEREFORE, on motion of the Acting Floor Leader, the Honorable Kagawad Mendola, seconded by the Honorable Kagawad Torrevillas; be it

"RESOLVED, to acknowledge the assumption to office of the newly appointed Kagawads, the Honorable Manuel F. Fiel, vice Cesar S. Samson, deceased, and the Honorable Jose C. Alfaro, Jr., vice Dionisio S. Santiago, resigned, pursuant to the appointment signed by His Excellency President Ferdinand E. Marcos dated February 1, 1985, indorsed by the Honorable Minister of Local Government dated February 20, 1985;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, the City Mayor, the City Treasurer, the City Auditor and the Kagawads concerned, all in Ormoc City.
