THROUGH THE REGIONAL DIRECTOR, BUREAU OF LANDS TRANSPORTATION,
TACLOBAN CITY, THAT ONE LICENSING MACHINE BE ASSIGNED IN OR-
MOC CITY.

"WHEREAS, Kagawad Bandalan, in his capacity as Chairman on Trans-
portation and Communications of the Sangguniang Panlungsod ng Ormoc has
manifested that there is a necessity of even one licensing machine to
be assigned in Ormoc City for the convenience of the drivers to renew
their respective licenses;

"WHEREAS, the renewal of the drivers licenses is being done in the
Regional Office, Tacloban City to the risk and burden on the part of the
drivers incurring too much expenses in coming back and forth;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded by Kagawad
Torrevillas; be it

Director Bureau of Land Transportations, Tacloban City to assign one li-

Manila, the Regional Director, Bureau of Land Transportations, Tacloban
