THE EARLY RELEASE OF FIRST QUARTER OF 1985 BARANGAY
ROADS MAINTENANCE FUNDS ALLOTMENT OF ORMOC CITY.

"WHEREAS, there is a need to facilitate the release of
the Ormoc City allotments of Barangay Roads Maintenance Funds
for First Quarter of 1985 considering the greater impact of
the on-going Barangay Roads projects some of which to be
finished during this dry season;
