RESOLUTION NO. 1712

A RESOLUTION INTEGRATING THE INTENDED WATERWORKS REPAIR SHOP IN CONNECTION WITH THE IMPLEMENTATION OF THE BA-RANGAY WATERWORKS PROJECT WITH THE MANPOWER DEVELOP-MENT PROGRAM OF THE CITY OF ORMOC USING IN THE MEAN-TIME THE MANPOWER DEVELOPMENT BUILDING, EQUIPMENT AND THE PHYSICAL PLANT FOR THE PURPOSE.

"WHEREAS, at the outset the principal aim of the Barangay Waterworks Program (BWP) of the Ministry of Local Government is to develop the capabilities of local governments particularly in the field of planning, financial management, and infrastructure so that they may pursue their own water supply efforts;

"WHEREAS, Ormoc City entered into a Memorandum of Agreement with the Barangay Water Program sometime in 1982 promising among others to comply with the participation requirements, as a result, a seed money of \$\frac{7}{251,400.00}\$ was released to Ormoc City to initiate construction of Seven Stars Barangay Waterworks project;

"WHEREAS, recently, Barangay Water Program Recertification Team visited Ormoc City and found a deficiency in our participation requirements, one of which, is the need for a waterworks repair shop, in order to be eligible for the Phase II project, i.e., Iuna-Simangan Barangay Program;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Mendola.

"RESOLVED, to integrate the intended waterworks repair shop in connection with the implementation of the Barangay Water Project with the Manpower Development Program of Ormoc City using in the meantime the Manpower Development building, equipment and the physical plant for the purpose;

"RESOLVED, FURTHER, to furnish a copy of this Resolution each to the Barangay Water Program Recertification Team, Ministry of Local Government, Metro Manila, the City Development Coordinator, City Planning and Development Office, the City Development and Management Officer, Ministry of Local Covernment, Ormog Branch Office, both of Ormog City. Local Government, Ormoc Branch Office, both of Ormoc City; "CARRIED UNANIMOUSLY."
