RESOLUTION NO. 1719

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS, THROUGH THE HONORABLE MINISTER OF NATIONAL DEFENSE THRU PROPER CHANNEL, THE EXTENSION OF THE TOUR OF DUTY OF MAJOR ALFREDO T. QUIBIN AS STATION COMMANDER OF ORMOG CITY, POLICE STATION FOR A PERIOD OF ONE YEAR.

"WHEREAS, we have been reliably informed that the Integrated National Police Station Commander, Major Alfredo T. Quibin's tour of duty will end sometime in July, 1985;

"WHEREAS, to the Ormocanons, Major Quibin is the most efficient and conscientious station commander that the city ever had for which reason we would like him to stay for one year more for our greater benefit and general well-being;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded jointly by Mga Kagawad Alfaro, Hermosilla and Codilla; be it

"RESOLVED, to earnestly request His Excellency President Ferdinand E. Marcos, through the Honorable Minister of National Defense and proper channel, the extension of the Tour of Duty of Major Alfredo T. Quibin as Station Commander of Ormoc City Police Station for a period of one more year;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency President Ferdinand E. Anacleto P. Arque, Jr., Provincial Commander, Fort Area, Bonifacio Road, Tacloban City; and Major Alfredo T. Quibin, INP Station Commander, Ormoc City;
