RESOLUTION NO. 1724

A RESOLUTION EARNESTLY REQUESTING HONORABLE MINISTER JESUS T. HIPOLITO, MINISTER OF PUBLIC WORKS AND HIGHWAYS THAT ORMOC CITY SHOULD BE INCLUDED IN THE TRANSFER OF FUNDS FOR THE MAINTENANCE OF BARANGAY ROADS AND BRIDGES AND CONSTRUCTION, REHABILITATION, BETTERMENT AND IMPROVEMENT (CRBI) PROJECTS.

"WHEREAS, this august body is aware of the fact that other local government units are now taking charge of the maintenance of barangay roads and bridges, as well as the Construction, Rehabilitation, Betterment and Improvement (CRBI) projects in their respective localities;

"WHEREAS, we would like also to take charge of same projects considering that Ormoc City Local Government has just acquired a payloadler, road grader, road roller and six dump trucks, all of these are brand new which can supplement our present barangay equipments, and, therefore, capable of doing the job;

"WHEREAS, the city government has capable engineers who can take care of the technical supervision of projects in the city. Right now we have already planned to shift engineers to supervise said barangay projects, if given to us and these engineers of the local roads section have better contact and relation with the barangay officials thru their respective Kagawads of the Sangguniang Panlungsod of Ormoc City;

"WHEREAS, problems of barangay officials are directly relayed to the Local Chief Executive and to his duly authorized representatives, and are promptly acted upon;

"WHEREAS, it has been observed that the national government is in fiscal restraint, and that additional hiring of technical men to man the barangay section would only add obligatory expense which would inconvenience or burden the national government financially;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded by Kagawad Mendola; be it

"RESOLVED, to earnestly request Honorable Minister Jesus T. Hipolito, Minister of Public Works and Highways that Ormoc City should be included in the transfer of funds for the maintenance of barangay roads and bridges and Construction, Rehabilitation, Betterment and Improvements (CRBI) Projects;
