RESOLUTION NO. 1725

A RESOLUTION INFORMING THE MINISTRY OF LOCAL GOVERNMENT THAT THE REAL PROPERTY TAX ASSESSMENT REGULATION NO. 1-84 AND LOCAL TREASURY REGULATION NO. 6-84 DATED NOVEMBER 19, 1984 WERE RECEIVED BY THE CITY OF ORNOC ON JANUARY 3, 1985 AND EARNEST-LY REQUESTING GRADUAL IMPLEMENTATION OF REALTY TAX INCREASES BEGINNING FISCAL YEAR 1987, 1988 AND 1989.

"WHIRMAS, the Honorable City Mayor is in receipt of a telegram from the Honorable Director Roa of the Ministry of Local Government dated March 20, 1985, asking views and opinions of the Sangguniang Panlungsod concerning effects of local government income on Real Property Tax Assessment Regulation No. 1-84 and Local Treasury Regulation No. 6-84 dated November 19, 1984 of the Ministry of Finance and approved by His Excellency, the President of the Philippines;

"WHEREAS, considering that our region had experienced the effects of two typhoons, "Nitang" and "Undang" resulting into declaring the region as calamity area:

"NOW, THEREFORE, on motion of Kagawad Besabella, duly seconded by Kagawad Mendola; be it

"RESOLVED, to inform the Ministry of Local Government that the Real Property Tax Assessment Regulations No. 1-84 and Local Treasury Regulation No. 6-84 dated November 19, 1984, were received by the City of Ormoc on January 3, 1985 and, likewise, earnestly request the gradual implementation of realty tax increases beginning fiscal year 1987, 1988 and 1989;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister Cesar S. Virata, Ministry of Finance and the Honorable Minister Jose A. Roño, Ministry of Local Government, both of Metro Manila; the City Treasurer and the City Assessor, this city, for their guidance a n d information;
